#### How to become a member of the ESHS

In order to become a member you will have to do two things:

## 1. Application

## 2. Payment

Pay your membership fees. The amount of the annual fees is:

- \* 200 Euros (minimum) for Supporting Members
- \* 100 Euros for Friends of the ESHS
- \* 100 Euros for Institutional Members (i.e. for an institution like a museum, a society, or any corporate body)
- \* 20 Euros for Individual Members. In order to have the bank transfer charges reduced, you are allowed to pay your membership fees for three years in advance in a single payment (which amounts for example to 60 Euros for individual members for the years 2005, 2006 and 2007).

# i. Fellowships, Studentships and Job Opportunities

Editor-in-chief for Technology and Culture Society for the History of Technology

Deadline: April 1, 2009

The Society for the History of Technology (SHOT) is seeking candidates who wish to be considered as the next editor-in-chief for its flagship journal, Technology and Culture. The editor's primary responsibility is to sustain and enhance the journal's preeminence in the history of technology. The editor is responsible for creating and supervising an effective editorial team, ensuring responsive relations with the officers and membership of SHOT (as well as with the journal's publisher), managing the journal's relationship with the host institution, coordinating the journal's web version (eTC), and conducting appropriate outreach on behalf of the field and the society.

SHOT is conducting an open search for the new editor-in-chief. Candidates should possess wide knowledge of the history of technology, a distinguished record of scholarly contributions, and willingness to actively cultivate existing and novel perspectives in this interdisciplinary field. Previous scholarly editorial experience is highly desired. To be considered for this position, candidates must submit detailed plans for hosting the journal's editorial offices at a new home institution. SHOT has the financial capacity to assist (modestly) in the support of the editorial offices, so the editor-in-chief will need to mobilize substantial resources as well. The relationship between the editor's home institution and the society will eventually be formalized through a signed contract.

The successful candidate will gradually assume full responsibilities beginning January 2010 so as to publish the January 2011 issue in timely fashion. The initial term of service is five years. SHOT anticipates a transition year during 2010, during which the incoming editor will work closely with the present editor-in-chief, John Staudenmaier, S.J., to achieve a smooth hand-off. Complete proposals are due 1 April 2009. The committee welcomes and encourages conversations with potential candidates as well as nominations of potential candidates. Candidates should obtain from the search chair a "detailed document" describing the editorial duties. Proposals-in the form of electronic copies of all documents (.doc or .pdf strongly requested)-should be sent via email to the search committee chair. Each proposal will consist of the following components:

- 1. Statement of editorial vision and intellectual agenda (3-4 pages)
- 2. Summary CV (maximum 3 pages for editor-in-chief; 1 page for others)
- 3. Detailed plan for new editorial team, including specific discussion of office space, computing facilities, and financial resources (minimum 3 pages)
- 4. Evidence of committed support from host institution (signed letters of support from department chair, supervisor, dean, and/or other institutional officers) Finalist candidates may be asked for additional materials.

Location: Sweden

Assistant Professor/Research Fellow in History of Science and Ideas at the Department of History of Science and Ideas. The position is for at least two years, and can be prolonged to four, starting January 1, 2010.

At Uppsala University History of Science and Ideas can look back to a long tradition. The first chair was inaugurated in 1932. Since then the department has expanded enormously and meanwhile an additional chair in History of Science with its own research unit has been established. Currently the Department has 10 teachers/researchers and 10 Ph.D.-students. We have a broad range of research fields, as for example History of Science, History of Philosophy, History of Medicine, Cultural History and Media History. The Department of History of Science and Ideas provides instruction in History of Science and History of ideas. The subject is taught at the undergraduate level, masterslevel and at Ph.D. level. There are about twenty staff members and doctoral students. Swedish is the primary language of instruction and seminars.

Job description: The position comprises research (85 %) and teaching at the undergraduate and graduate levels, as well as dissertation supervision. The applicant is expected to contribute to the development of research in History of Science and Ideas.

Eligibility: To be eligible for the position, the applicant must have a Ph.D. or an equivalent degree. Priority will be given to those who have received their doctoral degree no more than five years prior to the end of the application period. Pursuant to the Uppsala University Hiring Ordinance, general eligibility for teaching posts includes the broad ability required to carry out the duties of the position in full.

Ability to teach in Swedish or English is required. The successful applicant is expected to be able to teach in Swedish within two years of accepting the post.

Assessment criteria: In ranking eligible applicants, special attention will be paid to scholarly merits.

In assessing pedagogical skills, attention will be paid to documented experience of the planning, execution and evaluation of teaching, as well as of examination and thesis supervision. More general information can be found in the University's Guidelines for Recruitment of Faculty, chapter 7, "Guidelines for Qualifications Assessment in Recruiting Teaching Staff".

In this recruitment procedure, the University will primarily consider the candidate who, following a comprehensive assessment of competence and skills, together with documented qualifications, is judged to be best suited to carry out and further develop the duties and functions of the position and to contribute to the advancement of the subject and the Department.

Documented administrative experience and skills, the ability to co-operate and the capacity to work independently and take personal responsibility are also important qualifications for this post.

Attention will also be paid to the applicants' ability to interact with the community at large and to inform the public about research and other developments in the field.

The University strives to attain a more balanced gender distribution among its teachers, and therefore encourages women especially to apply for this position.

Application process: Applications must be written in English or Swedish and include the following documents in two hard copies:

- A list of qualifications and positions held, together with attested copies of diplomas, certificates and other documents mentioned.
- A brief summary of scholarship, teaching and other activities. Personal circumstances (such as parental leave) that the applicant deems relevant should be indicated in the resume of qualifications and experience.
- A brief description of planned research.
- A list of scholarly and teaching-related works mentioned. The applicant is to select no more than 10 pieces of work that s/he deems most representative or relevant, and provide an explanation for the selection.

The post-holder will also be expected to spend part of her/his time at the library and archive of the Linnean Society of London (which holds Linnaeus's papers). ## **Grants and Prizes**

Brooke Hindle Postdoctoral Fellowship in the History of Technology Fellowship Deadline: 2009-04-15

The Brooke Hindle Postdoctoral Fellowship in the History of Technology honors the contribution of Brooke Hindle to the work of the Society for the History of Technology and is made possible thanks to the generosity of his family.

The fellowship is for \$10,000 and may be used, as further detailed below, for any purpose

connected with research or writing in the history of technology for a period of not less than four months during the year following the award.

Applicants must hold a doctorate in the history of technology or a related field, normally awarded within the preceding four years, or expect to have graduated by the time of the award. (Those who graduated earlier and can demonstrate good reason why they should be considered as being at an early stage in their postdoctoral career—e.g., because of family commitments—may apply at the discretion of the committee chair.) Other awards may be held in conjunction with the Fellowship.

The proposal must be in a field related to the history of technology. Applicants should be intending either to prepare a dissertation for publication as articles or as a monograph, whether or not this involves fresh primary research, or to develop a new project based on primary research.

Applications must be in English. Please send a copy to each of the members of the committee, preferably by email, by April 15, 2009.

For those expecting to graduate, the application must include:

- 1. A 2500-word (maximum) summary of the dissertation and a sample chapter (no more than 50 pages)
- 2. A plan of work (1000-1500 words) for the period of the fellowship
- 3. Two letters of recommendation, one from a scholar not on the applicant's dissertation committee or thesis advisory panel, and one as appropriate from the chair of the dissertation committee or the thesis supervisor, certifying that the applicant will complete the dissertation by the deadline and explaining the dissertation's strengths.

For those holding the doctoral degree and intending to publish their dissertation as articles or a book, the application should include:

- 1. A 2500-word (maximum) summary of the dissertation and a sample chapter (no more than 50 pages)
- 2. A plan of work (1000-1500 words) for the period of the fellowship
- 3. Two letters of recommendation. For applicants in full-time employment, one letter must include confirmation that an appropriate period of release will be granted. Ideally, the second letter should come from a colleague outside the employing institution.

Applicants are strongly urged to also submit copies of letters of interest from potential publishers or similar supporting material.

For those holding the doctoral degree and working towards a new project beyond the dissertation, the application should include:

- 1. A 2500-word (maximum) summary of the dissertation and a statement concerning published work derived from it
- 2. An outline (2500-5000 words) of the new project's focus, relevant literature, source material, and a plan of work for the period of the fellowship
- 3. Two letters of recommendation. For applicants in full-time employment, one letter must include confirmation that an appropriate period of release will be granted. Ideally, the second letter should come from a colleague outside the employing institution.

#### Scientific Instrument Society research grants

The Scientific Instrument Society awards small grants for research on the history of scientific instruments.

The grants are worth up to £500 each, and the Society will commit a maximum of £1,500 in the calendar year. Grants may be used to cover any costs of research, including travel and photography. They should enable new research, rather than funding activities to which the applicant is already committed; they are not intended to support conference travel, unless there is a specific research dimension.

The grants are open to all applicants without restriction: both members and non-members may apply. Applications can be submitted at any time and will be reviewed by the Society's Committee, whose decision is final.

Successful applicants are expected to report on the results of their research to the Society, either at a meeting or through publication in the Society's Bulletin.

\* Master's Degree Bursaries: bursaries of £1,000 to support students taking taught

Master's courses in the history of science or technology. Non-members of the Society are eligible. Deadline: 30 September each year.

- \* Research Grants: small grants for specific research purposes, from £50 to £500. There are two cycles per year. Only members of the Society are eligible. Deadlines: 30 September and 31 March each year.
- \* Butler-Eyles Travel Grants: grants of up to £100 to assist with the travel costs of attending a BSHS conference. Only student members of the Society are eligible. There are multiple cycles: candidates should apply by the registration deadline for the relevant conference.
